# Structure, Governance & Management

#### Structure

Inverkeithing Trust is a Scottish Charitable Incorporated Organisation (SCIO) reg no SC050365. We are governed by our constitution (adopted July 2020). The Trust was granted charitable status by the Office of the Scottish Charity Regulator (OSCR) on 31 July 2020.

#### Governance

The Trust is governed by its constitution (adopted July 2020).

Membership of the Trust is free and is open to anyone aged 16 years or over who lives in Inverkeithing. At 31 March 2023, the Trust had **101** members.

The Trust board members are the charity's trustees.

Any Trust member is eligible to become a trustee if they support and wish to help achieve the purposes of the organisation.

Trustees are elected at the Annual General Meeting, which is normally held in October or November. Under the constitution, there must be a minimum of four and not more than 12 trustees.

#### Management

Trustees meet on a regular basis. They must always act in the interests of the charity and do their best to achieve the charity's purposes and objectives. They are responsible for the direction and management of the organisation.

The Trust has relevant policies in place and holds comprehensive public liability insurance.

#### Charitable purposes and aims

Inverkeithing Trust is established for charitable purposes only. We aim to:

 Advance citizenship, community development and volunteering within and for the benefit of the community defined by the Inverkeithing Community Council area by delivering a diverse variety of services and initiatives without distinction of sex, sexuality, political, religious, or other opinion, with the object of improving their conditions of life.

- 2. Improve the mental and physical health and well-being of all the inhabitants of the Inverkeithing Community Council area by facilitating non-clinical, community led activity from various sites across the community of Inverkeithing.
- 3. Advance education and learning by providing workshops, training sessions and courses in the community of Inverkeithing.
- 4. Advance the culture, art, and heritage of Inverkeithing through a variety of initiatives.
- 5. Advance environmental protection or improvement through a variety of initiatives, including re-purposing vacant and derelict land into accessible and productive green space, to benefit all the inhabitants of the Inverkeithing Community Council area.
- 6. Provide recreational facilities and organise recreational activities to improve the conditions of life of all the inhabitants of the Inverkeithing Community Council area.

# What have we been doing?

### **Projects & Activities**

### Community Shop & Café

Our Food for Thought community shop & café at Ballast Bank community centre continues to thrive. It's become such a warm and welcoming space for all our fabulous customers and volunteers alike. This past year has brought changes and challenges. The food pantry has been going since June 2020 with customers purchasing pre-packed bags. But in October 2022, we were able to take this to the next level with our shop and café. Now customers choose what they want from the selection available on the



shelves, fruit & veg, bread & rolls, cakes and items from the freezer. Why not pay us a visit and enjoy a friendly chat, a laugh (or a moan) along with a cuppa, home baking and a hot snack. The shop & café are open to the whole community every Wednesday 9.30 – 11.30 am at Ballast Bank community centre in Preston Crescent. Spread the word!


**School holiday fun activities:** Our 'summer fun at the Bally' was held every Wednesday afternoon at Ballast Bank from 1.00 to 3.00 pm throughout the school summer holidays. Children received a free lunch and took part in games and arts & crafts activities.

An additional activities fortnight was held on Wednesdays during the school October holidays. The projects were funded by Fife Council's Café Inc programme and were organised and managed by Trust pantry volunteers.



**Christmas Fayre:** In December 2022, along with other groups in the town, Trust volunteers helped the Community Council with its Christmas Fayre. Townsfolk turned out in force and it was a great success with lots of stalls, storytelling, owls galore, choir singing, free food for children and, of course, Santa! The 2023 Christmas Fayre is to be held on Friday 1 December.

**Prestonhill and Quarry:** In March 2021, at the request of Trust members, Inverkeithing Trust and Community Council carried out a joint survey to find out what the community thought about the DDR Ltd proposals to develop the Quarry site for housing. Analysis of the survey showed that the majority of Inverkeithing respondents were against housing on this site. On that basis, and with independent advice from Planning Aid Scotland, the Trust then submitted formal objections to the proposals and strengthened these again in a further joint letter with the Community Council.



On 16 February 2022 the Council's Planning Committee refused the DDR application, which was appealed by DDR to the Scottish Government Reporter. After a site visit with local groups, Fife Council and DDR representatives, the Reporter reached a decision in September 2022 to refuse the application.

DDR submitted a further planning application on 7 December 2022 which, at the time of writing, is still to be put before the Council's Planning Committee for consideration. We will do our best to keep the community informed.

**Garden Competition:** We revived the town's much missed Garden Competition in August 2021. The competition got bigger and better in 2022 as we also resurrected the Flower Show.

**Basic cooking classes:** The free cooking classes which started in March 2022 continued to be very popular with all ages, genders and abilities. In the autumn 2022 they moved to the Treetops Nursery and became part of Fife Council's Adult Learning programme where they continue to be well-attended. Our grateful thanks go, once again, to the cooking tutor, Shona Wilson, who is a Fife Council Senior Early Years/Family Liaison Officer at Treetops and a Fife Community Food Champion.

**Coastal path:** We're continuing to look at how we can make the Inverkeithing section of the path more interesting for everyone who uses it by putting up information and storyboards about our town and its rich history along the way.



**Working groups:** Trust members sat on various working groups throughout the year eg Food Resilience and Town Centre Regeneration (Public Realm Works).

### **Future Projects**

By working to its charitable purposes, the Trust's main aim is to help build a strong, vibrant community in Inverkeithing and to 'join the dots' for townspeople by keeping them informed about what's happening in the town.

As well as progressing the projects already mentioned in this report, the Trust is also evolving and developing new ideas or planning for new projects – again all are dependent on time and resources available.

**Swift nesting boxes:** A few Trust members have agreed to install nesting boxes on their house walls in the early summer in an area where swifts have been previously spotted.

It's hoped the boxes will be used by the swifts to help prevent their population declining further in our town and will encourage these amazing little birds back in greater numbers. We'll report back next year!

**Sunday pop-up café:** At some point in 2023, Fife Council will be installing a new kitchen at Ballast Bank community centre, where we currently operate our Food for Thought community shop & café on Wednesday mornings. Once the kitchen works are completed, the Trust hopes to also start a Sunday morning pop-up café that will be open to the community and visitors alike. Watch this space!

**Environmental/bio-diversity survey:** The Trust will be appointing an ecological consultant to undertake a survey of the town's flora and fauna to help us protect and improve habitats where it's possible for us to do so, starting with specific focus on a section of the coastal path in 2023. We hope this will help us to improve the quality of our open and green spaces, understand better what needs to be protected and where biodiversity could be improved.

**Local Place Plan:** In March 2023, Trust members attended a workshop with Planning Aid Scotland to understand better what a Local Place Plan is all about. It's hoped the Trust can work with the Community Council and others to bring a group together to engage with the community and prepare a draft Plan for Inverkeithing. The draft would be presented to Fife Council for discussion and, hopefully, acceptance. Local Place Plans are part of the new planning legislation and are very important – we don't want Inverkeithing to be left behind.

# Independent Examiner's Report to the Trustees of **Inverkeithing Trust**

I report on the accounts of the charity for the year ended 31 March 2023 which are set out in this report.

#### Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities

# 1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities & Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

# 2 Nature and purpose of funds

Unrestricted funds are those that may be used at the discretion of the trustees in furtherance of the objects of the charity. At 31 March 2023, the Trust has unrestricted funds of £13,352.

Restricted funds may only be used for specific purposes. Restrictions arise when specified by the donor or when funds are raised for specific purposes. At 31 March 2023, the Trust has restricted funds of £3,359 as follows:
